**This application for membership is made subject to the following conditions:**

1. All applications for playing memberships shall be passed upon and approved or rejected by the Director of Golf of Ocean Resorts WWCC Golf Club.
2. A playing membership, when issued, shall be non-transferable.
3. A playing membership includes golf privileges only, subject to all conditions hereafter set forth, and does not include any share, interest or ownership of any kind in Ocean Resorts WWCC Golf Club. Playing privileges under all memberships shall be subject to such rules and regulations as are adopted from time to time by Ocean Resorts WWCC Golf Club.
4. Minimum prepaid dues of \$200.00 (Non-Refundable) shall accompany each application. Balance is due within 30 days.
5. Should a member become delinquent in the payment of dues, he or she may continue to play by paying regular rates for green fees.
6. Ocean Resorts WWCC Golf Club reserves the right, at any time, to cancel the playing privileges of any member with a pro-rated refund of prepaid dues to be determined by the Director of Golf.
7. Types of playing memberships:
  - A. Single Membership - \$600.00 per year \$1,200 per year with cart
  - B. Family Membership - \$800.00 per year \$1,500 per year with cart
    - **\*\*NOTE\*\*** Family membership includes: Husband, Wife, and two children under the age of 16 living in the same household. Additional children may be added for \$50.00 per year.
8. Membership year runs from April 1 through March 31. Members joining after April 1 are pro-rated at the rate determined by the Director of Golf.
9. Memberships include:
  - A. Unlimited golf, during the golf courses' normal business hours, with assigned tee-times.
  - B. Walking of the course is allowed anytime except on extremely busy days as determined by the Director of Golf.
  - C. Advanced tee-times may be taken up to (7) seven days in advance.
  - D. 10% discount off of golf shop merchandise.
  - E. Participation in special "Members Only" promotions during the year.
  - F. Riding cart fee of \$20.00 per person for 18 holes is not included in membership fee.
  - G. Unlimited range balls included with membership.

## **Ocean Resorts WWCC Golf Club, LLC Golf Rules and Regulations**

- 1. The Director of Golf, Golf Shop Staff, Golf Superintendent, Starter, and Ranger shall be agents of the owners of Ocean Resorts WWCC Golf Club and shall enforce all rules and regulations pertaining to golf.**
- 2. All persons playing golf must first register in the golf shop prior to teeing off. (Spectators allowed only when permission of the Starter or Golf Shop staff is secured.)**
- 3. Unauthorized person(s) shall not be permitted to walk, ride, swim, fish or hunt on golf course premises.**
- 4. All children (12) twelve years of age and younger may play only when accompanied by an adult.**
- 5. Agents of Ocean Resorts WWCC Golf Club may remove a golfer, or golfers, from the golf course for flagrant violations of course rules or etiquette (e.g., obnoxious behavior, intoxication, damage of course, refusal to let golfers through when holding up play, or failure to follow the course design on a hole-by-hole basis, etc.).**
- 6. Agents may remove a beginner from the course when the beginner cannot reasonably hit the ball or keep up with the pace of play.**
- 7. Each golfer must have a set of clubs and bag before teeing off. (Rental clubs are available in the Golf Shop).**
- 8. A group of golfers less than a foursome on weekends, holidays and busy weekdays, may be assigned to play with other golfers by the starter or Golf Shop staff in order to maintain pace of play.**
- 9. Ocean Resorts WWCC Golf Club may restrict a golfer or golfers from the course for a specified amount of time for flagrant or repeated violation of golf rules.**
- 10. No person shall play golf on the course after the Superintendent or agent, because of weather or certain maintenance practices, has closed it.**
- 11. No vehicles other than golf carts shall be permitted on golf course without the permission of the Director of Golf or the Superintendent.**
- 12. The golf starter or golf shop staff shall be responsible for assigning foursomes and placing them on the course.**
- 13. No person shall submit false information for the purpose of securing golf privileges.**
- 14. During wet conditions, carts may be restricted to cart paths only or other areas at the discretion of the Director of Golf, Superintendent or agent.**
- 15. Golfer must be (16) sixteen years of age or older to operate a power cart. Operator assumes responsibility for the safe operation and return of the golf cart during the round of golf.**
- 16. Proper attire must be worn on the golf course. Men's' tank tops, cut-off jeans and t-shirts are prohibited.**
- 17. Please use proper golf course etiquette. Rake bunkers, repair ball marks and replace divots.**
